



Terms and Conditions

1.0 Your Acceptance of the Terms and Conditions

BY USING AND/OR VISITING THIS WEBSITE (collectively, including all Content available through the WHATSONBROADBANDTV WBBTV.COM domain name, referred to as the "WBBTV Website", or "Website"), YOU SIGNIFY YOUR ASSENT TO THESE TERMS AND CONDITIONS. If you do not agree to any of these terms, then please do not use the WBBTV Website.

2.0 WBBTV Website

These Terms of Service apply to all users of the whatsonbroadbandtv WBBTV Website, ("WBBTV" or "WBBTV Website"). The WBBTV Website may contain links to third party websites. WBBTV assumes no responsibility for, the content, privacy policies, or practices of any third party websites. In addition, WBBTV will not and cannot censor or edit the content of any third-party site. By using the Website, you expressly relieve WBBTV from any and all liability arising from your use of any third-party website. Accordingly, we encourage you to be aware when you leave the WBBTV Website and to read the terms and conditions and privacy policy of each other website that you visit.

3.0 User Submissions

A. WBBTV hereby grants you permission to use the Website, provided that: (i) your use of the Website as permitted is solely for your personal, noncommercial use; (ii) you will not copy or distribute any part of the Website in any medium without WBBTV's prior written authorization; (iii) you will not alter or modify any part of the Website other than as may be reasonably necessary to use the Website for its intended purpose; and (iv) you will otherwise comply with the terms and conditions of these Terms of Service.

B. In order to access some features of the Website, you will have to create an account. You may never use another's account without permission. When creating your account, you must provide accurate and complete information. You are solely responsible for the activity that occurs on your account, and you must keep your account password secure. You must notify WBBTV immediately of any breach of security or unauthorized use of your account. Although WBBTV will not be liable for your losses caused by any unauthorized use of your account, you may be liable for the losses of WBBTV or others due to such unauthorized use.

C. You agree not to use or launch any automated system, including without limitation, "robots," "spiders," "offline readers," etc., that accesses the Website in a manner that sends more request messages to the WBBTV servers in a given period of time than a human can reasonably produce in the same period by using a convention on-line web browser. Notwithstanding the foregoing, WBBTV grants the operators of public search engines permission to use spiders to copy materials from the site for the sole purpose of creating publicly available searchable indices of the materials, but not caches or archives of such materials. WBBTV reserves all rights not expressly granted in and to the Website and the Content. You agree to not engage in the use, copying, or distribution of any of the Content other than expressly permitted herein, including any use, copying, or distribution of User Submissions of third parties obtained through the Website for any commercial purposes. If you download or print a copy of the Content for personal use, you must retain all copyright and other proprietary notices contained therein. You agree not to circumvent, disable or otherwise interfere with security related features of the WBBTV Website or features that prevent or restrict use or copying of any Content or enforce limitations on use of the WBBTV Website or the Content therein.

5.0 User Submissions

A. The WBTV Website may now or in the future permit the submission of videos or other communications submitted by you and other users ("User Submissions") and the hosting, sharing, and/or publishing of such User Submissions. You understand that whether or not such User Submissions are published, WBTV does not guarantee any confidentiality with respect to any submissions.

B. You shall be solely responsible for your own User Submissions and the consequences of posting or publishing them. WBTV does not endorse any User Submission or any opinion, recommendation, or advice expressed therein, and WBTV expressly disclaims any and all liability in connection with User Submissions. WBTV does not permit copyright infringing activities and infringement of intellectual property rights on its Website, and WBTV will remove all Content and User Submissions if properly notified that such Content or User Submission infringes on another's intellectual property rights. WBTV reserves the right to remove Content and User Submissions without prior notice. WBTV will also terminate a User's access to its Website, if they are determined to be a repeat infringer. A repeat infringer is a User who has been notified of infringing activity more than twice and/or has had a User Submission removed from the Website more than twice. (ii) Identification of the copyrighted work claimed to have been infringed, or, if multiple copyrighted works at a single online site are covered by a single notification, a representative list of such works at that site;

(iii) Identification of the material that is claimed to be infringing or to be the subject of infringing activity and that is to be removed or access to which is to be disabled and information reasonably sufficient to permit the service provider to locate the material;

(iv) Information reasonably sufficient to permit the service provider to contact you, such as an address, telephone number, and, if available, an electronic mail;

(v) A statement that you have a good faith belief that use of the material in the manner complained of is not authorized by the copyright owner, its agent, or the law; and

(vi) A statement that the information in the notification is accurate, and under penalty of perjury, that you are authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.
